TENANTS SERVICE

The Tenants Service provides information and advice to Illawarra and South Coast tenants (private, public and those who permanently reside in a residential park).

Workers may assist tenants appearing before the NSW Civil and Administrative Tribunal (NCAT).

WELFARE RIGHTS

We provide information and advice to Illawarra and South Coast people having problems with Centrelink.

Among other things, our financial counsellors can assist clients to identify and understand their options, taking into account their individual financial and other circumstances. We can offer information and support to clients who choose to pursue one or more of those options and may be able to assist in negotiations with other parties on a client's behalf.
